SWORN STATEMENT OF FACTS – ATTACHMENT TO GENERAL AFFIDAVIT

AFFIANT / VICTIM: Tara Ramage (f/k/a Tara Busby)

SUSPECT: Jarrod Fusco

CHARGE: Conspiracy (Miss. Code § 97-1-1) and Telecommunications Harassment (Miss. Code § 97-29-45)

I, Tara Ramage (formerly known as Tara Busby), being first duly sworn, depose and state that the following facts are true and correct to the best of my knowledge and belief:

1. I am a resident of Harrison County, Mississippi, and am employed as the Code Enforcement Administrator for the City of Biloxi.
2. The suspect, Jarrod Fusco, operating the digital Facebook publication "Biloxi Politics Uncensored", entered into a criminal conspiracy with Yuri Petrini to amplify, distribute, and weaponize electronic communications with the specific intent to terrify, intimidate, degrade, and harass me.
3. On March 6, 2026, the suspect utilized his electronic broadcasting platform to actively distribute and promote a harassing article written by his co-conspirator, Petrini.
4. In this electronic publication, the suspect posted a degrading cartoon caricature of me and explicitly amplified an abusive slur, writing: "The apology is specifically for the headline that called Tara Busby a 'crackhead'".
5. The suspect's deliberate act of re-publishing, amplifying, and distributing this lewd and harassing language was completely devoid of any legitimate informational or public purpose, and was done in coordination with Petrini to maximize the severe distress, humiliation, and harassment inflicted upon me.
6. This coordinated electronic communication violates Mississippi Code § 97-29-45 (Telecommunications Harassment) and Mississippi Code § 97-1-1 (Conspiracy to commit a misdemeanor).
7. Attached to this sworn statement is a true and accurate printed copy of the electronic Facebook publication containing the unlawful language and imagery cited above.

8. I am requesting that this Sworn Statement of Facts be attached to the General Misdemeanor Affidavit and submitted to the Honorable Municipal Court Judge for the immediate issuance of an arrest warrant for Jarrod Fusco.

I declare under penalty of perjury that the foregoing is true and correct.

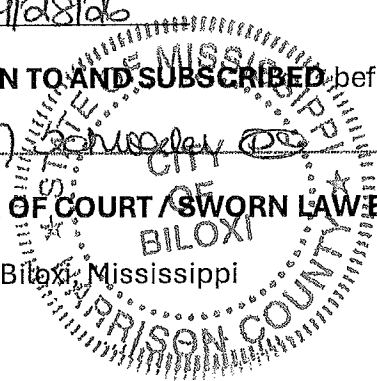
