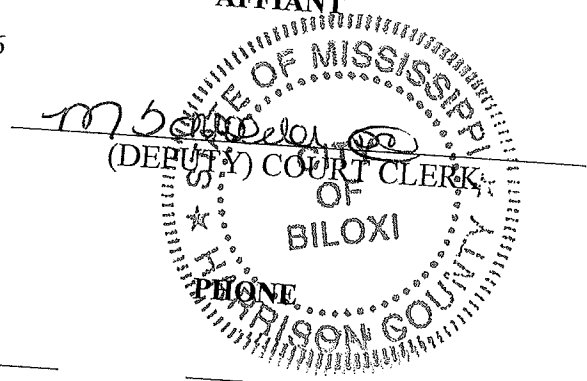

SWORN STATEMENT OF FACTS – ATTACHMENT TO GENERAL AFFIDAVIT

AFFIANT / VICTIM: Tara Ramage (f/k/a Tara Busby)

SUSPECT: Yuri Petrini

CHARGE: Telecommunications Harassment (Miss. Code § 97-29-45)

I, Tara Ramage (formerly known as Tara Busby), being first duly sworn, depose and state that the following facts are true and correct to the best of my knowledge and belief:

1. I am a resident of Harrison County, Mississippi, and am employed as the Code Enforcement Administrator for the City of Biloxi.
2. The suspect, Yuri Petrini, operating the digital publication website "People vs Biloxi" (peoplevsbiloxi.com), utilized electronic communications and internet telecommunications with the specific intent to terrify, intimidate, degrade, and harass me.
3. In March 2026, the suspect published and electronically distributed an article titled "The Crackhead of Code Enforcement — Part 01".
4. Within this electronic communication, the suspect repeatedly utilized lewd, lascivious, indecent, and profoundly abusive language directed personally at me, completely devoid of any legitimate informational or public purpose.
5. The suspect's published electronic harassment explicitly included referring to me as a "whore-looking tramp".
6. The suspect further utilized electronic communications to intentionally degrade my appearance, my parenting, and my character, publishing that I am "a mediocre looking tramp", stating that I am a "single mom living a life that is the pure child of 'incompetence'", and referring to me as "The woman who looks like she enforces nothing except her next hit".
7. This electronic communication was distributed publicly online, causing severe distress, humiliation, and harassment, in direct violation of Mississippi Code § 97-29-45, which prohibits the use of telecommunications or electronic communications to make lewd or indecent comments with the intent to terrify, intimidate, or harass.
8. Attached to this sworn statement are true and accurate printed copies of the electronic publication containing the unlawful language cited above:

9. I am requesting that this Sworn Statement of Facts be attached to the General Misdemeanor Affidavit and submitted to the Honorable Municipal Court Judge for the immediate issuance of an arrest warrant for Yuri Petrini.

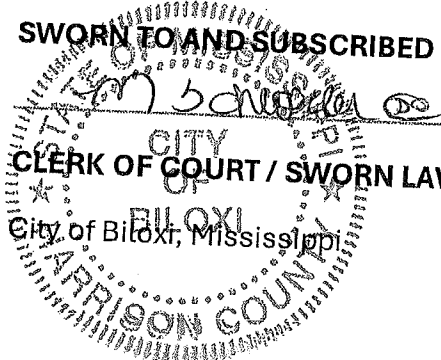
